Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.	
WHAT?	The types of personal information we collect, and share depend on the product or service you have with us. This information can include:  • Social Security number and income  • Account balances and payment history  • Credit history and credit scores	
HOW?	All financial companies need to share customer's personal information to run their everyday business. In the section below, we list the reasons financial companies can share their member's personal information, the reasons Greenbax Marketplace, INC chooses to share and whether you can limit this sharing.

DEFINITIONS		
Affiliates	Companies related by common ownership or control. They can be financial and nonfinancial companies.	
Non-affiliates	Companies not related by common ownership or control. They can be financial and nonfinancial companies.  • Non-affiliates we share with can include mortgage servicing companies, credit and debit card processors, insurance companies, credit reporting bureaus and investment services companies	
Joint Marketing	A formal agreement between nonaffiliated financial companies that together market financial products or services to you
