



## **SMS Privacy Policy**

**1. Introduction** We value your privacy and are committed to protecting your personal information. This SMS Privacy Policy explains how we collect, use, and safeguard the information you provide when subscribing to our SMS services.

**2. Information We Collect** Your information is collected and safeguarded when you apply for an account with Greenbax Marketplace Inc. When you subscribe to our SMS services, we may collect the following information:

- Your mobile phone number
- Your name, address
- Your business information
- Your email address
- Any other information you provide.

**3. Use of Information** The information we collect is used for the following purposes:

- To send you SMS messages related to the onboarding process for your account.
- To respond to your inquiries and provide customer support.
- To update you on the relevant account information and ensure all account information remains current and compliant.
- To improve our services and offerings

**4. Sharing of Information** We do not sell, trade, or otherwise transfer your personal information to outside parties, except as described below:

- We may provide your personal information to agents or service providers acting on our behalf for limited purposes. Specifically, we may share your information with trusted third party service providers who assist us in operating our SMS services, conducting our business, or serving you, provided those parties agree to keep this information confidential.

Additionally, we reserve the right to disclose your personal information as required by law (e.g., to comply with a subpoena, warrant, court order, or similar legal process served on our us) and when we believe that disclosure is necessary to protect our rights, protect your safety or the safety of others, investigate fraud, and/or respond to a government request. In certain situations, we may be required to disclose personal data in response to lawful



requests by public authorities, including meeting national security or law enforcement requirements. To the extent that we are permitted, we will always alert you to such outside requests or demands for information.

**5. Security of Your Information** We care about protecting the security of your personal information, and we have implemented security procedures to protect the personal information that you provide to us. However, no method of transmitting or storing electronic data is ever completely secure, and we cannot guarantee that such information will never be accessed, used, or released in a manner that is inconsistent with this policy. We implement a variety of security measures to maintain the safety of your personal information. Your information is stored in secured networks and is only accessible by a limited number of persons who have special access rights to such systems and are required to keep the information confidential.

**6. Your Consent** Whenever you submit information to us as part of your account opening process and subscribe to our SMS service, you consent to the collection, use, and disclosure of that information in accordance with this Privacy Policy.

**7. Opting Out** You can opt-out of receiving SMS messages from us at any time by replying "STOP" to any message you receive. After opting out, you will no longer receive SMS messages from us, but you may still receive emails or other communications if you have opted in to them.

**8. Changes to Our Privacy Policy** We may update our SMS Privacy Policy from time to time. We will notify you of any changes by posting the new policy on our website. You are advised to review this policy periodically for any changes.
